Before making payment the ALC concerned shall ensure that: -

1. The case is Genuine.
2. The beneficiary is actual Building and Other Construction Worker as defined under section 2 (e) of the Act.
3. Payment is to be made to the rightful claimant.
4. The payment should be made through electronic transaction/Invoice. In rare cases payment can be made through P/A cheque to the beneficiary where electronic transaction is not possible.
5. The payments to the construction worker may be made after strict verification so that money could not go waste.
6. Before making the payment the ALC shall complete all the requisite codal formalities.
7. He will maintain all the requisite record before making the payment.
8. The payments shall be made strictly in accordance with Rules and the guidelines issued from time to time.
9. If at any time it is found that the payment has been made to a non genuine person the ALC shall be held personally responsible.
10. The ALC concerned shall request to the Head of Educational Institutions to refund the amount if the candidate/student has availed any such type of scholarship from any other source.
