Sub: Release of Medical assistance in favour of registered BOC worker namely, Santokh Raj, S/o. Pritam Raj, R/o. Bhagthali, District Kathua having Regt. No. 6293 dated 29/9/2014.

ORDER

Sanction is hereby accorded to the release of Rs. 26250.00 (Rupees Twenty six thousand two hundred and fifty only) on account of Medical assistance in favour of registered BOC worker namely, Santokh Raj, S/o. Pritam Raj, R/o. Bhagthali, District Kathua having Regt. No. 6293 dated 29/9/2014 who has been suffered with 35% Disability as per Disability Certificate issued by the O/o. CMO Health & F.W. Kathua. The assistance is being released in terms of Rule 22-S (3) of SRO 373 dated 12/11/2012 of JKBOCW WB.

The Assistant Labour Commissioner concerned shall release the payment on the following terms and conditions that:-

1. The beneficiary is a genuine & registered Building & Other Construction Worker as defined under section 2(e) of the JKBOCW WB Act.
2. The payment is made to the rightful claimant.
3. **Before making the payment, the ALC shall complete all the Codal formalities and maintain in the proper record, besides, ensuring that the beneficiary has not availed the assistance for the said purpose during the current financial year.**
4. The payment shall be made strictly in accordance with the Rules and Guidelines issued by JKBOCW WB from time to time.
5. Before making the payment, every entry in the Passbook shall be completed and arrears on account of Monthly Contribution fee, if any, shall also be received under rules.
6. The U.C. / Red Accounts shall be submitted by the ALC at the end of every month without waiting for the call from this office.

It is further clarified that this office shall not be responsible for any wrong payment to a wrong person.
