**Sub:- Release of Financial assistance on account of Death cum Funeral charges in case of deceased BOC worker namely, Lt. Habibullah Reshi, S/o. Mahmood Reshi, R/o. ReshiPora, District Kishtwar bearing Regt. No. 7771 Dated 21/6/2013.**

### ORDER

Sanction is hereby accorded to the release of **Rs. 205000.00 (Rupees two lacs & Five thousand only)** as Financial assistance on account of **Death & Funeral assistance** in favour of legal heirs / dependents of deceased registered BOC worker namely, **Lt. Habibullah Reshi, S/o. Mahmood Reshi, R/o. ReshiPora, District Kishtwar bearing Regt. No. 7771 Dated 21/6/2013.** The payment shall be made to the dependent family members of the deceased BOC worker strictly as per **Dependent Certificate issued by the Competent Authority and after fulfilment of all codal formalities.**

The Assistant Labour Commissioner shall release the payment on the following terms and conditions that:-

- I. The ALC concerned shall re-verify the case and satisfy himself that the case is genuine
- II. The deceased person was actual Building & Other Construction Worker as defined under section 2(e) of the JKBOCWWB Act.
- III. The Payment shall be made through Payees Account cheque / DBT mode to the beneficiaries strictly as per share of dependents / legal heirs.
- IV. **Before making the payment, the ALC shall complete all the requisite Codal formalities and maintain the proper record.**
- V. The receipt and acquaintance roll be submitted to this office after payment within 10 days positively.
- VI. The payment in case of minor, if any, shall be kept in Fixed Deposit till maturity.
- VII. The ALC shall personally verify the case regarding the dependents of the deceased worker. If one of them is /are dead or was living in separation prior to the death of the worker or was not dependent on the deceased then their share of amount shall be equally distributed among rest of the dependent / legal heirs.
- VIII. The ALC shall verify that the deceased BOC worker had paid his MCF before his death and was a valid beneficiary on the date of his death.
