following terms and conditions that:-

The Assistant Labour Commissioner concerned shall re-verfy the case and I. satisfy himself that the case is genuine.

The deceased person was actual Building and Other Construction Worker as II.

defined under Section 2-(e) of the Act

The payment should be made through payees account cheque/DBT Mode to III. the beneficiary strictly as per the share of legal heirs.

The receipt and acquaintance roll be submitted to this Office after payment IV. within 10 days positively.

The payment of minor should be kept in fixed deposit till maturity. V.

The ALC shall personally verify the case regarding the dependent of VI. deceased, if any one of them is/are dead or was living in separation prior to his death or was not dependent on the deceased then their amount shall be equally distributed in rest of dependents/legal heirs.

The ALC shall also verify that if any one of the daughter/daughters of VII. deceased is/are married then the payment of those shall be equally

distributed in rest of the dependents.
