Sub: Release of financial assistance Death cum Funeral Charges in Case of deceased registered construction worker namely Lt Ab Khaliq Ahanger S/o Mohammad Rustam Ahanger R/o Cheepora Lolab District Kupwara bearing registration No. 7280 dated 20.01.2013 for his legal heirs/dependents.

ORDER

Sanction is hereby accorded to the release of Rs. 205000/- (Rupees two lac and five thousand only) as Financial Assistance on account of Death Assistance and Funeral Assistance to the legal heirs/dependents of the deceased registered construction worker Lt Ab Khaliq Ahanger S/o Mohammad Rustam Ahanger R/o Cheepora Lolab District Kupwara bearing registration No. 7280 dated 20.01.2013. **The payment may be made to the dependents/nominees of the deceased construction worker only after obtaining the dependent certificate issued by the competent authority and fulfillment of all codal formalities.**

The Assistant Labour Commissioner, Kupwara shall release the payment on the following terms and conditions that:-

- I. The Assistant Labour Commissioner concerned shall re-verify the case and satisfy himself that the case is genuine.
- II. The deceased person was actual Building and Other Construction Worker as defined under Section 2-(e) of the Act
- III. The payment should be made through payees account cheque/DBT Mode to the beneficiary strictly as per the share of legal heirs.
- IV. The receipt and acquaintance roll be submitted to this Office after payment within 10 days positively.
- V. The payment of minor should be kept in fixed deposit till maturity.
- VI. The ALC shall personally verify the case regarding the dependent of deceased, if any one of them is/are dead or was living in separation prior to his death or was not dependent on the deceased then their amount shall be equally distributed in rest of dependents/legal heirs.
- VII. The ALC shall also verify that if any one of the daughter/daughters of deceased is/are married then the payment of those shall be equally distributed in rest of the dependents.
