Sub: Sanction of death assistance in favour of the dependents of the deceased registered construction worker (beneficiary) namely Late. Gh. Ahmad Rather S/o Habibulla Rather R/o Ajas District. Bandipora bearing registration Number 9456 dated 22-08-2012

ORDER

Sanction is hereby accorded to the release of Rs.205000/- (Rupees two lac five thousand only) as financial assistance on account of Death assistance and funeral assistance to the legal heirs/ dependents of the deceased registered construction worker namely Late Gh. Ahmad Rather Reg. No. 9456 dated 22-08-2012. The deceased has been expired on 12-02-2016. **The payment may be made to the dependent/nominees of the deceased Construction worker only after obtaining the dependent certificate issued by the competent authority and fulfillment of all codal formalities.**

The Assistant Labour Commissioner, Bandipora Shall release the payment on the following terms and conditions that:-

- 1 The Assistant Labour Commissioner Shall re-verify the case and satisfy himself that the case is genuine.
- 2 The deceased person was actual Building and Other Construction Worker as defined under Section 2-(e) of the Act
- 3 The payment should be made through Electronic transaction or payees A/c Cheques/Bank invoice to the beneficiary strictly as per the share of legal heirs.
- 4 Receipt and acquaintance roll be submitted to this office after payment within 10 days positively.
- 5 The payment of minor should be kept in fixed deposit till maturity.
- 6 The ALC Shall personally verify the case regarding the dependents of deceased,if any one of them is/are dead or was living in separation prior to his death or was not dependent on the deceased then their amount shall be equally distributed in rest of dependents./legal heirs.
- 7 The ALC Shall also verify that if any one of the daughter/daughters of deceased is/are married then the payment of those shall also be equally distributed in rest of dependents.
