Sub:- Release of Financial assistance on account of Chronic Disease Assistance in case of BOC worker namely, Altaf Hussain Malik, S/o. Gh. Mohd. Malik, R/o. Dangarpora, District Baramulla, bearing Regt. No. 30925 dated 26/4/2016.

ORDER

Sanction is hereby accorded to the release of **Rs. 24915.00 (Rupees Twenty four thousand nine hundred and fifteen only)** as Financial assistance on account of **Chronic disease assistance** in favour of registered BOC worker namely, **Altaf Hussain Malik, S/o. Gh. Mohd. Malik, R/o. Dangarpora, District Baramulla, bearing Regt. No. 30925 dated 26/4/2016.** The payment shall be made to the BOC worker only after fulfilment of all codal formalities.

The Assistant Labour Commissioner shall release the payment on the following terms and conditions that:-

- a. The payment is made to the rightful claimant & it should be ensured that the recipient is actual Building & Other Construction worker as defined under section 2(e) of the JKBOCW WB Act.
- b. **Before making the payment, the ALC shall complete all the codal formalities and will maintain the proper record and ensure that the beneficiary has not availed the assistance for the said purpose for the relevant financial year.**
- c. The payment shall be made strictly through Account Payee Cheque / DBT mode and in accordance with the Rules and Guidelines issued by JKBOCW WB from time to time.
- d. Before making the payment, every entry in the Passbook shall be completed and arrears on account of Monthly Contribution Fee (MCF), if any, shall also be received under rules.
- e. The U.C. / Red Accounts shall be submitted by the ALC at the end of every month without waiting for the call from this office.

It is further clarified that this office shall not be responsible for any wrong payment to a wrong person.
