## ORDER

Sanction is hereby accorded to the release of Rs. 105000.00 (Rupees One Lakh and five thousand only) as Financial assistance on account of Death cum Funeral assistance in favour of Dependent family members of deceased BOC worker namely, Late Saroop Chand, S/o. Jai Ram, R/o. Palmar, District Kishtwar, Regt. No. 1365 dated 02.1.2012.

The Assistant Labour Commissioner shall release the payment on the following terms and conditions that:-

- The ALC concerned shall re-verify the case and satisfy himself that the case is genuine. a.
- b. The deceased person was actual Building & Other Construction Worker as defined under section 2(e) of the JKBOCWWB Act.
- The Payment shall be made through Payees Account cheque / DBT mode to the beneficiaries C. strictly as per share of dependents / legal heirs.
- Before making the payment, the ALC shall complete all the requisite Codal formalities and d. maintain the proper record.
- The receipt and acquaintance roll be submitted to this office after payment within 10 days e. positively.
- The payment in case of minor, if any, shall be kept in Fixed Deposit till maturity. f.
- The ALC shall personally verify the case regarding the dependents of the deceased worker. If one g. of them is /are dead or was living in separation prior to the death of the worker or was not dependent on the deceased then their share of amount shall be equally distributed among rest of the dependent / legal heirs.
- The ALC shall re-verify that the deceased BOC worker had paid his MCF before his death and h. was a valid beneficiary on the date of his death.
