Sub: Release of Education assistance in favour of BOC worker, Bihari Lal, S/o. Badri Nath, R/o. Padyarana, District Kishtwar, Regt. No. 7495, Dated 15/5/2013.

ORDER

Sanction is hereby accorded to the release of Rs. 50,000.00 (Rupees Fifty thousand only) on account of Education assistance in favour of BOC worker namely, Bihari Lal, S/o. Badri Nath, R/o. Padyarana, District Kishtwar, Regt. No. 7495, Dated 15/5/2013 for mitigating the Education expenditure of his ward namely, Vishal Kumar who was pursuing B.Tech. (Civil Engg.), 3rd / 4th Semester, Session 2018-19 at Aryans College of Engg. Nepra Thua Rajpura, Chandigarh.

The Assistant Labour Commissioner concerned shall release the payment on the following terms and conditions that:-

1. The beneficiary is a genuine & registered Building & Other Construction Worker as defined under section 2(e) of the JKBOCW WB Act.
2. The payment is made to the rightful claimant.
3. Before making the payment, the ALC shall complete all the codal formalities and will maintain the proper record and ensure that the beneficiary has not availed the assistance for the said Semester / Session from JKBOCW WB or from any other Govt. Agency / Department.
4. The payment shall be released in favour of the concerned College / Institute where the ward of the worker is pursuing higher studies. If the fee is already deposited by the worker, then the amount shall be released in favour of the worker subject to the receipt of NDC from the concerned College/ Institute.
5. The payment shall be made strictly in accordance with the Rules and Guidelines issued by JKBOCW WB from time to time.
6. Every entry in the Passbook shall be completed before making the payment and arrears on account of Monthly contribution Fee, if any, shall also be received under rules.
7. The U.C. / Red Accounts shall be submitted by the ALC at the end of every month without waiting for the call from this office.

It is further clarified that this office shall not be responsible for any wrong payment to a wrong person.
