Sub: Release of Financial Assistance on account of Chronic Disease Assistance in case of Sh. Ab. Rashid Malik S/o Ab. Majeed Malik R/o Adigam District Kulgam bearing registration No. JK-1022 dated 10.09.2018

ORDER

Sanction is hereby accorded to the release of Rs. 37363/- (Rupees Thirty Seven Thousand Three Hundred Sixty Three only) in favour of Sh. Ab. Rashid Malik S/o Ab. Majeed Malik R/o Adigam District Kulgam bearing registration No. JK-1022 dated 10.09.2018 for mitigating the expenditure as his wife namely Malla Naznina was suffering from Chronic/Life Consuming disease "Chronic Calcific Pancreatitis". The payment shall be made in favour of the construction worker as he has already incurred the amount involved.

The Assistant Labour Commissioner, Kulgam shall release the payment on the following terms and conditions that:-

- i. The Assistant Labour Commissioner concerned shall re-verify the case and satisfy himself that the case is genuine.
- ii. The payment is made to the rightful Claimant.
- iii. The beneficiary is a genuine Building & Other Construction Worker as defined under Section 2(e) of the Act.
- iv. The payment should be made through Electronic transaction or payees A/c Cheques/Bank Invoice to the beneficiary strictly as per the share of legal heirs.
- v. Before making the payment, the ALC shall complete all the requisite codal formalities and shall maintain the proper record and ensure that the beneficiary has not availed the said assistance in the current year.
- vi. The payment shall be made strictly in accordance with the rules & guidelines issued by JKBOCWWB from time to time.
- vii. Before making the payment every entry in the passbook shall be completed and arrears on account of Monthly contribution shall also be received under Rules.
- viii. The UC/Red Accounts shall be submitted by ALC at the end of the month without waiting for the call from this office.

It is further clarified that this office shall not be responsible for any wrong payment to a wrong person.
