

→ **Terms & Conditions:-**

The above mentioned funds may be released for expenditure on financial assistance to the transporters who have shifted to the registered construction work on the following terms and conditions:

- I. An amount of Rs 1000/- per worker may be released to registered workers strictly through DBT.
- II. There shall be no public gathering at the concerned assistant labour commissioner offices.
- III. The beneficiary is actual Building and Other Construction Workers as defined under section 2(e) of the Act.
- IV. Payment is to be made to the rightful claimant.
- V. It is further clarified that this office shall not be responsible for any wrong payment to a wrong person.
- VI. The payment to the construction worker may be made after strict verification so that money could not go waste.
- VII. Before making the payment the ALC shall complete all the requisite codal formalities.
- VIII. ***He will maintain all the requisite record/ separate register before making the payment.***
- IX. The payment shall be made strictly in accordance with Rules and the guidelines issued from time to time.
