**ORDER**

Sanction is hereby accorded to the release of **Rs. 40,588.00** (Rupees Forty thousand five hundred and eighty eight only) on account of **Chronic / Life consuming disease Assistance** in favour of Registered BOC worker namely, **Fayaz Ahmad Reshi, S/o. Gh. Rasool Reshi, R/o. Repora payeen, District Ganderbal, Regt. No. JK0115004107 Dated 16/3/2019** to meet his medical expenditure as he is suffering from Chronic / Life consuming disease. **Only Post-Regt. period medical bills of the worker have been considered for release of assistance in favour of the worker.**

The Assistant Labour Commissioner concerned shall release the payment on the following terms and conditions that:-


1. The beneficiary is a genuine & registered Building & Other Construction Worker as defined under section 2(e) of the JKBOCWBB Act.
2. The payment is made to the rightful claimant.
3. **Before making the payment, the ALC shall complete all the Codal formalities and maintain in the proper record, besides ensuring that the beneficiary has not availed the assistance for the said purpose for the related year.**
4. The payment shall be made strictly in accordance with the Rules and Guidelines issued by JKBOCWBB from time to time.
5. Before making the payment, every entry in the Passbook shall be completed and arrears on account of Monthly Contribution fee, if any, shall also be received under rules.
6. The U.C. / Red Accounts shall be submitted by the ALC at the end of every month without waiting for the call from this office.
