Sub: Release of Financial assistance on account of Death cum Funeral Assistance in case of BOC worker namely, Shamus Din Lone, S/o. Gulum Mohd. Lone, R/o. Marhama Khoribal, District Kupwara, Regt. No. 5175 dated 27/12/2013.

ORDER

Sanction is hereby accorded to the release of Rs. ~~2,05,000.00~~ (Rupees Two Lakh and five thousand only) as Financial assistance on account of **Death cum Funeral assistance** in favour of Dependent family members of deceased BOC worker namely, Shamus Din Lone, S/o. Gulum Mohd. Lone, R/o. Marhama Khoribal, District Kupwara, Regt. No. 5175 dated 27/12/2013. **However, payment shall be released in favour of dependents family members after receiving the deficient documents viz. Dependent Certificate issued / countersigned by the Competent Authority (ADC / ACR) and Original Regt. Card of the deceased worker (Affidavit in case the same is misplaced / Lost)** as desired vide this office letter No. CEO/J&K/BCB/020/F-538/1061 dated 11.01.2021.


The Assistant Labour Commissioner concerned shall release the payment on the following terms and conditions that:-

- a. The ALC concerned shall re-verify the case and satisfy himself that the case is genuine.
- b. The deceased person was actual Building & Other Construction Worker as defined under section 2 (e) of the JKBOCW WB Act.
- c. The Payment shall be made through Payees Account cheque / DBT mode to the beneficiaries strictly as per share of dependents / legal heirs.
- d. Before making the payment, the ALC shall complete all the requisite Codal formalities and maintain the proper record.
- e. The receipt and acquaintance roll be submitted to this office after payment within 10 days positively.
- f. The payment in case of minor, if any, shall be kept in Fixed Deposit till maturity.
- g. The ALC shall personally verify the case regarding the dependents of the deceased worker. If one of them is /are dead or was living in separation prior to the death of the worker or was not dependent on the deceased then their share of amount shall be equally distributed among rest of the dependent / legal heirs.
- h. The ALC shall re-verify that the deceased BOC worker had paid his MCF before his death and was a valid beneficiary on the date of his death.

(This issues with the approval of Hon'ble Chairman, JKBOCW WB).

It is further clarified that this office shall not be responsible for any wrong payment to a wrong person.
