OFFICE ORDER NO : 255 -JKBOCWWB of 2021
DATED : 15 -07-2021

Sub: Release of financial assistance Death cum Funeral Charges in Case of deceased registered construction worker namely Lt Gh Rasool Bhat S/o Ali Mohmad Bhat R/o Dal District Srinagar bearing registration No. SB-12725 dated 27.02.2013 for his legal heirs/dependents.

ORDER

Sanction is hereby accorded to the release of Rs. 205000/- (Rupees two lac and five thousand only) as Financial Assistance on account of Death Assistance and Funeral Assistance to the legal heirs/dependents of the deceased registered construction worker Lt Gh Rasool Bhat S/o Ali Mohmad Bhat R/o Dal District Srinagar bearing registration No. SB-12725 dated 27.02.2013. The payment may be made to the dependents/nominees of the deceased construction worker only after obtaining the dependent certificate issued by the competent authority and fulfillment of all codal formalities.


The Assistant Labour Commissioner, Srinagar shall release the payment on the following terms and conditions that:-

- I. The Assistant Labour Commissioner concerned shall re-verify the case and satisfy himself that the case is genuine.
- II. The deceased person was actual Building and Other Construction Worker as defined under Section 2-(e) of the Act
- III. The payment should be made through payees account cheque/DBT Mode to the beneficiary strictly as per the share of legal heirs.
- IV. The receipt and acquaintance roll be submitted to this Office after payment within 10 days positively.
- V. The payment of minor should be kept in fixed deposit till maturity.
- VI. The ALC shall personally verify the case regarding the dependent of deceased, if any one of them is/are dead or was living in separation prior to his death or was not dependent on the deceased then their amount shall be equally distributed in rest of dependents/legal heirs.
- VII. The ALC shall also verify that if any one of the daughter/daughters of deceased is/are married then the payment of those shall be equally distributed in rest of the dependents.
