**Sub: Release of Chronic / Life consuming disease assistance in favour of registered BOC worker namely, Mohd. Yousuf Wani, S/o. Gh. Mohd. Wani, R/o. Sadurkoot Bala, District Bandipora, Regt. No. 8501, Dated 30/12/2011.**

**ORDER**

Sanction is hereby accorded to the release of **Rs. 75,746.00** (Rupees Seventy five thousand Seven Hundred & Forty six only) on account of **Chronic / Life consuming disease assistance** in favour of registered BOC worker namely, **Mohd. Yousuf Wani, S/o. Gh. Mohd. Wani, R/o. Sadurkoot Bala, District Bandipora, Regt. No. 8501, Dated 30/12/2011** to meet medical expenditure of his son who suffered from Chronic / Life consuming disease.

The Assistant Labour Commissioner concerned shall release the payment on the following terms and conditions that:-

1. The beneficiary is a genuine & registered Building & Other Construction Worker as defined under section 2(e) of the JKBOCWBB Act.
2. The payment is made to the rightful claimant.
3. **Before making the payment, the ALC shall complete all the Codal formalities and maintain in the proper record, besides ensuring that the beneficiary has not availed the assistance earlier for the said purpose for relevant year.**
4. The payment shall be made strictly in accordance with the Rules and Guidelines issued by JKBOCWBB from time to time.
5. Before making the payment, every entry in the Passbook shall be completed and arrears on account of Monthly Contribution fee, if any, shall also be received under rules.
6. The U.C. / Red Accounts shall be submitted by the ALC at the end of every month without waiting for the call from this office.
