- i) That the beneficiary is a genuine & active Building & Other Construction Worker as defined under section 2(e) of the JKBOCW WB Act.
- ii) That the payment is made to the rightful claimant.
- iii) That the payment shall be made through payees account cheque/DBT mode to the beneficiary and proper record of all the releases shall be maintained.
- iv) That all the requisite Codal formalities are observed and ensure that the beneficiary has not availed the said assistance in the current year to avoid duplicity.
- v) That the payment shall be released in favour of the concerned institution / college. In case of reimbursement to the worker, NOC of the institution/College shall be obtained.
- vi) That the payment shall be made strictly in accordance with the Rules and Guidelines issued by JKBOCW WB from time to time.
- vii) That the UC/MPR shall be submitted by ALC at the end of every month without waiting for call from this office.
- viii) That the instructions issued vide this office letter No. CEO/J&K/BCB/2021/1711-37 dated 06/10/2021 should be observed in letter & spirit.
