Sub: Release of financial assistance Death cum Funeral Charges in Case of deceased registered construction worker namely Late Fayaz Ahmad Khan S/o Lt Gulam Ahmad R/o Sofi Gund Wanpoh District Anantnag bearing registration No. JK0111001436 dated 29.09.2018 for his legal heirs/dependents.

ORDER

Sanction is hereby accorded to the release of Rs. 205000/- (Rupees two lakh and five thousand only) as Financial Assistance on account of Death Assistance and Funeral Assistance to the legal heirs/dependents of the deceased registered construction worker Late Fayaz Ahmad Khan S/o Lt Gulam Ahmad R/o Sofi Gund Wanpoh District Anantnag bearing registration No. JK0111001436 dated 29.09.2018. **The payment may be made to the dependents/nominees of the deceased construction worker only after obtaining the dependent certificate issued by the competent authority and fulfillment of all codal formalities.**

The Assistant Labour Commissioner Anantnag shall release the payment on the following terms and conditions that:-

- I. The Assistant Labour Commissioner concerned shall re-verify the case and satisfy himself that the case is genuine.
- II. The deceased person was actual Building and Other Construction Worker as defined under Section 2-(e) of the Act
- III. The payment should be made through payees account cheque/DBT Mode to the beneficiary strictly as per the share of legal heirs and after actual verification to ensure that the benefit goes to actual beneficiary.
- IV. The receipt and acquaintance roll be submitted to this Office after payment within 10 days positively.
- V. The payment of minor should be kept in fixed deposit till maturity.
- VI. The ALC shall personally verify the case regarding the dependent of deceased, if any one of them is/are dead or was living in separation prior to his death or was not dependent on the deceased then their amount shall be equally distributed in rest of dependents/legal heirs.
- VII. The ALC shall also verify that if any one of the daughter/daughters of deceased is/are married then the payment of those shall be equally distributed in rest of the dependents.
- VIII. The Instructions (Alert Note 83/2021) issued vide this office letter No. CEO/J&K/BCB/2021/1711-37 dated 06.10.2021 should be followed in letter & sprit
