Subject: Release of Financial assistance on account of **Death cum Funeral assistance** in case of BOC worker namely Lt. Mohd. Shakeel S/o Mohd. Latief District Poonch bearing registration No. 28106/P dated 15/12/2014 for his legal heirs/dependents.

ORDER NO: 405/JKBOCWWB OF 2024

Sanction is hereby accorded to the release of Rs. 205000/- (Rupees Two Lakhs and five thousand only) as Financial Assistance on account of Death and funeral Assistance to the legal heirs/dependents of the deceased registered construction worker. **The Payment may be made to the dependents/nominees of the deceased construction worker only after obtaining the dependent certificate issued by the competent authority and fulfillment of all Codal formalities.**

The Assistant Labour Commissioner shall release the payment on the following terms & Conditions:-

- The Assistant Labour Commissioner concerned shall re-verify the case and satisfy himself that the case is genuine.
- **The ALC concerned is directed to explain the issue of the delay in submission of the case and reply of the queries before releasing the payment in the instant case within 07 days without fail.**
- The deceased person was actual Building & Other Construction Worker as defined under section 2(e) of the BOCW Act, 1996.
- That the payment is made to the rightful claimant.
- The payment shall be made through payees account cheque/DBT mode to the beneficiary strictly as per the share of legal heirs and after actual verification to ensure that the benefit goes to actual beneficiary.
- The receipt and acquaintance roll be submitted to this office after payment within 10 days positively.
- The payment of minor should be kept in fixed deposit till maturity.
- The ALC shall personally verify the case regarding the dependent of deceased, if any one of them is/are dead or was living in separation prior to his death or was not dependent on the deceased then their amount shall be equally distributed in rest of dependents/legal heirs.
- The ALC shall also verify that if any one of the daughter/daughters of the deceased is/are married then the payment of those shall be equally distributed in rest of the dependents.
- The instructions (Alert Note 83/2021) issued vide this office letter no. CEO/J&K/BCB/2021/1711-37 dated 06/10/2021 should be followed in letter & spirit.
