Sub: Release of Death Assistance and Funeral Charges in case of deceased registered Construction Worker namely Late Saifuddin Wani S/O Gh. Ahmad Wani R/o Sumlar Shokbaba District Bandipora Regd NO. (13154) dated. 02.01.2013 for his legal heirs/dependents.

ORDER

Sanction is hereby accorded to the release of Rs. 205000/- (Rupees Two Lakh Five thousand only) under Rule 22-P&Q of SRO-373 Dated: 12-11-2012 read with SRO-284 dated: 03-06-2013, as Financial Assistance on account of Death Assistance and funeral assistance to the legal heirs/dependents of the deceased registered construction worker Late Saifuddin Wani S/O Gh. Ahmad Wani R/o Sumlar Shokbaba District Bandipora Regd NO. (13154) dated. 02.01.2013. The payment shall be made to the dependents/nominees of the deceased construction worker only after obtaining the dependent & Death certificates issued by the competent authority and fulfilment of all other codal formalities.

The Assistant Labour Commissioner, Bandipora shall release the payment on the following terms and conditions that:-

- I. The Assistant Labour Commissioner concerned shall re-verify the case and satisfy himself that the case is genuine.
- II. The deceased person was actual Building and Other Construction Worker.
- III. The payment should be made through Electronic transaction or payees A/c Cheques/Bank Invoice to the beneficiary strictly as per the share of legal heirs.
- IV. The receipt and acquaintance roll be submitted to this office after payment within 10 days positively and follow the ACB Notes and other guidelines issued by this office from time to time
- V. The payment of minor should be kept in fixed deposit till maturity.
- VI. The ALC Shall Verify the MCF receipt details, before releasing the payment.
- VII. The ALC shall personally verify the case regarding the dependents of deceased, if any one of them is/are dead or was living in separation prior to his death or was not dependent on the deceased then their amount shall be equally distributed in rest of dependents/legal heirs.
- VIII. The ALC Shall also verify that if any one of the daughter/daughters of deceased is/are married then the payment of those shall also be equally distributed in rest of dependents.
- IX. *The Instructions (Alert Note 83/2021) issued vide this office letter No. CEO/J&K/BCB/2021/1711-37 dated 06.10.2021 should be followed in letter & spirit.*
