Sub: Release of Financial Assistance on account of Injury/Disability Assistance in the case of Shri. Ashaq Hussain Itoo S/o Ab Rahman Itoo R/o H.C Gam Distt. Kulgam bearing registration No. 3159 dated 05-03-2012.

**ORDER**

Sanction is hereby accorded to release of Rs. 37500/- (Rupees Thirty Seven Thousand Five Hundred only) under Rule 22-S (3) of SRO-373 dated 12-11-2012 as Disability Assistance in favour of Sh. Ashaq Hussain Itoo S/o Ab Rahman Itoo R/o H.C Gam Distt. Kulgam bearing registration No. 3159 dated 05-03-2012, on account of 50% Disability suffered by the Beneficiary due to Amputation left thumb, little finger and deformed ring finger, as indicated in Disability Certificate issued by Director SKIMS Srinagar vide his No: SIMS/15/16-1015 dated: 27-06-2016.

The Assistant Labour Commissioner, Kulgam shall release the payment on the following terms and conditions:-

- I. The beneficiary is a genuine Building and Other Construction Worker as defined under Section 2-(e) of the Act.
- II. The Payment is made to the rightful claimant directly through Direct Benefit Transfer (DBT) mode.
- III. The ALC shall re-verify the case and satisfy himself that the case is genuine before making the payment.
- IV. Before making the payment, the ALC shall complete all the requisite Codal Formalities and will maintain the proper record.
- V. The payment shall be made strictly in accordance with the Rules and Guidelines issued by J&K BOCWWB from time to time.
- VI. Before making the payment, every entry in the passbook shall be completed and arrears on account of Monthly Contribution shall also be received under Rules.
- VII. U.C/Red Accounts shall be submitted by ALC at the end of every month without waiting for the call from this office.
