Sub: Release of Financial Assistance on account of Chronic Disease Assistance case of Sh. Zahoor Ahmad Reshi S/o Mohd Yousf Reshi R/o Watlab, Sopore District Baramulla bearing registration No. JK0113007194 dated 25.05.2013.

ORDER

Sanction is hereby accorded to release of Rs. 37538/- (Rupees thirty seven thousand five hundred thirty eight only) in favour of Sh. Zahoor Ahmad Reshi S/o Mohd Yousf Reshi R/o Watlab, Sopore District Baramulla bearing registration No. JK0113007194 dated 25.05.2013 for mitigating the expenditure on account of treatment of his wife as she was suffering from Chronic Disease/ Life Consuming Disease "Acute Disseminated Encephalomyelitis". The payment should be made in favour of construction worker as he has already incurred the amount.

The Assistant Labour Commissioner Baramulla shall release the payment on the following terms and conditions, that: -

- I. The beneficiary is a genuine Building and Other Construction Worker as defined under Section 2-(e) of the Act.
- II. The payment is made to the rightful claimant.
- III. The Assistant Labour Commissioner concerned shall re-verify the case and satisfy himself that the case is genuine before making the payment.
- IV. Before making the payment, the ALC shall complete all the requisite Codal formalities and will maintain the proper record and ensure that the beneficiary has not availed the said assistance in the current year.
- V. The payment shall be made strictly in accordance with the Rules and Guidelines issued by J&K BOCWVB from time to time.
- VI. Before making the payment, every entry in the passbook shall be completed and arrears on account of Monthly Contribution shall also be received under Rules.
- VII. The U.C/Red Accounts shall be submitted by ALC at the end of every month without waiting for the call from this Office.
