Subject:- Release of Death Assistance in the case of deceased registered construction Worker namely Gh. Rasool Dar S/o Habibullah Dar R/o Muslim peer sopora Distt. Baramulla, bearing registration NO: 26366 dt: 15.2.2014 in favour of his legal heirs/dependents


ORDER

Sanction is hereby accorded to the release of Rs. 2,05,000 (Two lakh five thousand only) as Financial Assistance on account of Death Assistance to the legal heirs/ dependents of the deceased registered construction worker namely Gh. Rasool Dar S/o Habibullah Dar R/o Muslim Peer sopora, Distt. Baramulla, bearing registration NO: 26366 dt: 15.2.2014. The payment may be made to the dependents/nominees of the deceased construction worker only after obtaining the dependent certificate issued by the competent authority and fulfillment of all codal formalities.

The Assistant Labour Commissioner, Baramulla shall release the payment on the following terms and conditions that:-

- 1 The Assistant Labour Commissioner concerned shall re-verify the case and satisfy himself that the case is genuine.
- 2 The deceased person was actual Building and other Construction Worker as provided under the Act.
- 3 The payment should be made through Electronic transaction or payees A/c Cheques/Bank Invoice to the beneficiary strictly as per the share of legal heirs/dependents.
- 4 The receipt and acquaintance roll be submitted to this office after payment within 10 days positively.
- 5 The Payment of minor should be kept in fixed deposit till maturity.
- 6 The ALC shall personally verify the case regarding the dependents of deceased, if any one of them is / are dead or was living in separation prior to his death or was not dependent on the deceased then their amount shall be equally distributed in rest of dependents/legal heirs.
- 7 The ALC shall also verify that if any one of the daughter/daughters of deceased is / are married then the payment of those shall also be equally distributed in rest of dependents.
- 8 The ALC shall verify that the deceased BOC worker had paid the Monthly Contribution fee and was a valid beneficiary on the date of his death.
