**Sub: Release of Chronic disease assistance in favour of registered BOC worker namely, Sh. Surjeet Singh, S/o. Sh. Punjab Singh, R/o. Gagore Vijaypur, Samba, having Regt. No. 4188 dated 15.7.2013.**

**ORDER**

Sanction is hereby accorded to the release of Rs. 20608.00 (Rupees Twenty thousand six hundred and eight only) on account of Chronic / Life consuming disease assistance in favour of registered BOC worker namely, **Sh. Surjeet Singh, S/o. Sh. Punjab Singh, R/o. Gagore Vijaypur, Samba, having Regt. No. 4188 dated 15.7.2013** who has incurred the expenditure on account of medical treatment of his son namely, Arun Singh. **The assistance released in terms of Rule 22-V (2) of SRO 373 dated 12/11/2012 of JKBOCW WB against the medical bills submitted by the worker.**

The Assistant Labour Commissioner concerned shall release the payment on the following terms and conditions that:-

1. The beneficiary is a genuine & registered Building & Other Construction Worker as defined under section 2(e) of the JKBOCW WB Act.
2. The payment is made to the rightful claimant.
3. **Before making the payment, the ALC shall complete all the Codal formalities and maintain in the proper record besides ensuring that the beneficiary has not availed the assistance for the said purpose during the relevant year.**
4. The payment shall be made strictly in accordance with the Rules and Guidelines issued by JKBOCW WB from time to time.
5. Before making the payment, every entry in the Passbook shall be completed and arrears on account of Monthly Contribution fee, if any, shall also be received under rules.
6. The U.C. / Red Accounts shall be submitted by the ALC at the end of every month without waiting for the call from this office.

*It is further clarified that this office shall not be responsible for any wrong payment to a wrong person.*
