Sub: Release of financial assistance on account of Chronic Disease Case of Sh. Jugal Kishore S/o Gouri Shanker R/o Shakti Dhar Road District Udhampur bearing registration No .2894 dated. 31.10.2012

ORDER

Sanction is hereby accorded to release of Rs34,495.00 (Rupees Thirty Four Thousand Four Hundred Ninety Five Only) under Rule 22-V of SRO-373 dated: 12-11-2012, in favour of Sh. Jugal Kishore S/o Gouri Shanker R/o Shakti Dhar Road District Udhampur bearing registration No .2894 dated. 31.10.2012 on account of expenditure incurred by the beneficiary on treatment of his son who is suffering from Chronic/Life Consuming Disease.

The Assistant Labour Commissioner, Udhampur shall release the payment on the following terms and conditions:-

1. The beneficiary is a genuine Building and Other Construction Worker as defined under Section 2-(e) of the Act.
2. The Payment is made to the rightful claimant directly through Direct Benefit Transfer (DBT) mode.
3. The ALC shall re-verify the case and satisfy himself that the case is genuine before making the payment.
4. Before making the payment, the ALC shall complete all the requisite Codal Formalities and will maintain the proper record and ensure that the beneficiary has not availed the said assistance in the current year.
5. The payment shall be made strictly in accordance with the Rules and Guidelines issued by J&K BOCWWB from time to time.
6. Before making the payment, every entry in the passbook shall be completed and arrears on account of Monthly Contribution shall also be received under Rules.
7. U.C/Red Accounts shall be submitted by ALC at the end of every month without waiting for the call from this office.

It is further clarified that this office shall not be responsible for any wrong payment to a wrong person.
