Sub: Release of Financial Assistance on account of Education Assistance Case of Sh. Mohd Akli Sheikh S/o Gh Hassan Sheikh R/o Qaimoh District Kulgam bearing registration No. 9922 dated 06.11.2015.

ORDER

Sanction is hereby accorded to release of Rs. 30,000/- (Rupees Thirty thousand only) in favour of Mohd Akli Sheikh S/o Gh Hassan Sheikh R/o Qaimoh District Kulgam bearing registration No. 9922 dated 06.11.2015 for mitigating the expenditure on account of Professional Diploma Course of his son namely Nadeem Ahmad who is pursuing Electric Engineering 1st Semester Session 2018 in SSM College of Engineering & Technology, Parihaspora, Pattan.

The Assistant Labour Commissioner Kulgam shall release the payment on the following terms and conditions, that: -

- I. The beneficiary is a genuine Building and Other Construction Worker as defined under Section 2-(e) of the Act.
- II. The payment is made to the rightful claimant.
- III. The Assistant Labour Commissioner concerned shall re-verify the case and satisfy himself that the case is genuine before making the payment.
- IV. Before making the payment, the ALC shall complete all the requisite Codal formalities and will maintain the proper record and ensure that the beneficiary has not availed the said assistance in the current year.**
- V. The ALC Concerned shall check the age of the worker before making the payment.**
- VI. The payment shall be released in favour of the registered construction worker if the concerned Institute/College refuses to accept the cheque. The payment shall only be released in favour of construction worker subject to the production of NOC from concerned college/Institute.
- VII. The payment shall be made strictly in accordance with the Rules and Guidelines issued by J&K BOCWWB from time to time.
- VIII. Before making the payment, every entry in the passbook shall be completed and arrears on account of Monthly Contribution shall also be received under Rules.
- IX. The U.C/Red Accounts shall be submitted by ALC at the end of every month without waiting for the call from this Office.

It is further clarified that this Office shall not be responsible for any wrong payment to a wrong person.
