→ **Terms & Conditions:-**

The above mentioned funds may be released for expenditure on Welfare Scheme on the following terms and conditions:

1. All sanctioned cases on account of Ex-gratia etc. shall be cleared by Assistant Labour Commissioner's priority.
2. The beneficiary is actual Building and Other Construction Workers as defined under section 2(e) of the Act.
3. Payment is to be made to the rightful claimant.
4. The payment should be made through electronic transaction/invoice. In rare cases payment can be made through P/A cheque to the beneficiary where electronic transaction is not possible.
5. It is further clarified that this office shall not be responsible for any wrong payment to a wrong person.
6. The payment to the construction worker may be made after strict verification so that money could not go waste.
7. Before making the payment the ALC shall complete all the requisite codal formalities.
8. He will maintain all the requisite record before making the payment.
9. The payment shall be made strictly in accordance with Rules and the guidelines issued from time to time.
10. Before making the payment every entry in the passbook shall be completed and arrears on account of Monthly Contribution shall also be taken.

☞ **Important direction to be adhered to: -**

1. Amount sanctioned as such shall be released/ credited in the Official accounts of Assistant Labour Commissioner on demand from time to time after obtaining the detailed accounts alongwith the utilization certificates/ invoices of sanctioned cases.
2. Cases already sanctioned by CEO/Secretary shall be released firstly after due verification and following the terms and condition as already mentioned in the sanction order.
3. Cases of Assistance on A/c of Chronic disease and death shall be given on priority.
4. Assistant Labour Commissioner's shall clear all pendency on priority.
