After threadbare discussions/deliberations the following decisions were taken by the committee with regard to the agenda points as mentioned against each:-

1. Reservation for the children of registered construction workers in admission for various courses in it is: -

It was decided that J&K Building and Other Construction Workers Welfare Board will take up the matter with Technical Education Department for exploring the possibility of reservation of some seats for the children of registered Building and Other Construction workers in technical institutions i.e. ITI's Polytechnics etc. the seats reserved as such will be filled up on competitive basis from amongst the children of registered Building and Other Construction Workers. Alternatively, technical Education department also prepare a scheme to start special courses for the children of registered construction workers having better chances of employability and placement for which financial support of mutually agreeable level will be made available by the Board.

2. **Establishment of special ITIs near industrial hubs where sufficient population of workers reside for imparting vocational trainings to construction workers and their family members: -**

3. **Skill development/up-gradation of the Construction Workers to enable them to enhance their capabilities and output: -**

It was decided that a programme for skill development skill development/up-gradation of registered construction workers and their dependent children will be started with the active collaboration of the authorities of MSME Tool Room or institutions like CIPET, Amritsar and Panipet, CREDI other. Short term courses specially having more prospective of employability and profitability would be chosen for the purpose. All the expenditure including boarding lodging, travel etc shall be borne by J&K Building and Other Construction Workers Welfare Board on mutually agreeable terms and conditions (as finalized in the meeting headed by the Chief Secretary earlier at the Srinagar).

4. **Mobile facility for demonstration of latest tools and techniques of work at work places where construction workers are engaged, for up-gradation of their traditional skills: -**

It was decided that scheme will be prepared under which services of the suitable expert trainers shall be hired by the Board alongwith all the requisite tools and machines to impart the skill up-gradation / skill development training to the registered construction workers at work sites. For the purpose mobile vehicles could also be hired subject to properly spell out modalities.

The aforementioned decisions shall be placed before the Board / Hon'ble Chairman for approval.

The meeting ended with vote of thanks to the chairman.
